The Opportunity

We are seeking volunteer committee members with expertise and lived experience to provide insights and feedback on the accessibility initiatives eCampusOntario is supporting this year.

The Accessibility Advisory Group will:

- Act as a trusted advisor in providing expert input and guidance on eCampusOntario's accessibility initiatives, ensuring they align with AODA standards and best practices.
- Review the accessibility of various educational resources produced, including digital content, toolkits, and platforms.
- Raise awareness about accessibility issues in higher education and advocate for the implementation of accessible practices among post-secondary institutions.

- A deep understanding of accessibility principles, AODA compliance and inclusive design in the context of the post-secondary education sector.
- Experience in consulting or advisory roles related to accessibility and disability services.
- Familiarity with assistive technologies, digital accessibility guidelines, and accessible content creation.
- A commitment to championing accessibility and advocating for the rights of individuals with disabilities.
- Strong communication skills and the ability to work collaboratively with a diverse group of stakeholders.
- Experience in designing, delivering, or evaluating accessible courses.
- First-hand knowledge/experience of challenges, barriers and opportunities related to accessibility and inclusivity.
